the participant (the "Guardian"), in favor of Grace Lutheran Church: (the "Church"), its directors, officers, employees, and agents.

The Participant and Guardian do hereby freely, voluntarily, without duress execute this Release under the following terms:

- 1. Waiver and Release.** Participant and Guardian do hereby release and forever discharge and hold harmless the Church from any and all liability, claims demands of whatever kind of nature, either in law or in equity, which arise or may hereafter from the participant's and/or guardian's involvement in travel to and activities during field trip to the Farmory on Friday, July 26, 2019, and the Community Garden at Christ Community Church on Saturday, July 27, 2019.

Participant and Guardian understand that this release discharges the Church from any liability or claim that the Participant or Guardian may have against the Church with respect to any bodily injury, personal injury, illness, death or property damage that may result from their decision to participate in this event. Participant and Guardian also understand that the Church does not assume any responsibility or obligation to provide financial assistance or other assistance, including but not limited to medical, health, disability insurance.
- 2. Indemnification.** The Guardian and Participant shall assume liability for, be responsible for, indemnify (and at the Church's request, defend) and save harmless the Church and anyone to whom the Church may be liable by contract or otherwise, against any loss, damage or expense arising from any actual or claimed bodily injury, personal injury, illness, death, or damage to property, whether owned by you, the Church, third parties, including loss of use, which actually or allegedly results from or arises in connection with participation in this event. This includes, without limitation, and obligation of the guardian to indemnify the Church for payments to the Participant.
- 3. Other.** Participant and Guardian expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Wisconsin, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Wisconsin. Participant and Guardian agree that in the event any clause or provision of this Release shall be held to be invalid by any Court of competent jurisdiction, the validity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
